TENNIS REGISTRATION

With too many signups, singles would be eliminated. There will also be a Team Tennis format with four equal teams based on NTRP ratings.

The camaraderie and competition of Team Tennis is fun for everyone! Participants should plan on one TeamTennis match (10-game pro set in a variety of doubles combinations) each of the three days. Remember that because the TeamTennis scores are cumulative, players put their teammates at a disadvantage if they default a match. So, if you sign up for Team Tennis, you commit to playing for your team for all three days.
